

## NLOC Meeting Tuesday July 18, 2017 at 3:30 PM Portland Downtown – 549 Congress Street

1. Introductions: Sarah Martin opened the meeting and asked for introductions.

- 2. **Minutes**: Alen Saric made a motion to approve the June 20, 2017 meeting minutes. Jon Dow seconded the motion and the vote was unanimous.
- 3. Review Night Life Issues/Calls for Service/License for August renewals (attached):
  Lt. Cashman described the license renewal process and reviewed the calls for service in the packet.
  There was no discussion.
- 4. Review of new and pending liquor licenses for July 2017 (attached): Jessica Hanscombe reviewed.
  - Old port Tap House licensing (with regard to the addition of a tap house attached to the retail shop) has been discussed between the owner and Tony Austin, State Liquor Inspector
  - All licenses were approved

## 5. Other business:

- Sarah would like clarification of "extension of a sidewalk" re North Point on Silver Street and has sent another email to Mike Russell. She was told North Point was granted permission to use the sidewalk temporarily because it wasn't ADA compliant to begin with. However, several ordinance violations are currently in place. Casey suggested those present report the North Point patio through See Click Fix because it becomes public record. Sarah will report back to the committee with updates.
- Sarah would also like clarification of what a "shared street" is. Wharf Street is blocked by delivery trucks all the time. Casey suggested Sarah include Jeff Levine in her emails to Mike Russell as he may be able to clarify the definitions and acceptable uses for shared streets.
- In response to an inquiry made at last month's meeting, Jessica informed the committee that confiscated fake ID's should be sent to the DMV and provided a brochure with the address/instructions

- Bob had about 13 fake ID's in 2 shifts mostly the ID just was not the right person. If an establishment cracks down for one weekend, the word gets out that they might confiscate your fake ID and it reduces attempts.
- Fox Court is a hot spot for criminal behavior. Josh Miranda plans to install cameras and has a staff person do routine checks of the street/alley, but there are illegally parked cars where it's posted "no parking", late-night altercations, and public urination. Motion lights or bright lights could be helpful in deterring negative behaviors.
- Wharf Street is in need of pressure washing. Is it possible to get the water truck back overnight or early morning to clean the street?
- Casey will communicate the Wharf Street issues to John Peverada in the Parking Department and will contact Lt. McGary at PPD for special attention checks for Fox Court. Amy will reach out to Water Resources to find out about the water truck.
- Waterfront Concerts has not signed a 2018 contract with the City. There seems to be little interest by the City for them to stay and develop an infrastructure. Waterfront Concerts would like a 5-year lease in order to build infrastructure on the pier.
- The West Commercial Street cold storage project is going before City Council tonight
- The City's Sound Oversight Committee meets tonight at 5:00
