1. **Introductions:** Erik opened the meeting by welcoming everyone. Introductions were made.

2. **Review Night Life Issues/Calls for Service/License for July renewals (sent with the agenda):**
 - Don Krier reviewed the July calls for service in the packet
 - White Cap Grill has closed
 - Pai Men Miyake – fraud call: business checks were stolen and attempted cashing
 - Miyake and Portland Harbor Hotel loud music complaints: complaints were made by/from the hotel for hotel guests in response to noise coming from Wharf Street area businesses. Major Krier reviewed. Recordings over 92 decibels:
 - 9/11/15 – Oasis was at 100, 51 Wharf was at 100.
 - 9/18/15 Oasis was at 101 decibels
 - 10/2/15 Oasis was at 96
 - 1/28/16 and 4/8/16 – was loud when Pearls door was open.
 - 5/16, 6/11 and 8/6/16 - all loud music. Oasis and Bonfire were at 87 and 88. Two warnings were given to Oasis on 9/11/15.Committee discussion concluded that the Sound Oversight Committee should have been triggered. This group requested that Major Krier let PPD know that they should have called a meeting of the committee. Three in 30 days should trigger a meeting.
 - Elevation Burger – Maj. Krier reviewed dates of 3 fights reported
 - Old Port Slice Bar – shots heard on 11/16/15 merged with another call report says so no details.
 - Rosie's – liquor law violation = allowed intoxicated person to stay on premises 7/18/15. Officer spoke to person and spoke to manager. Violation of paperwork = probation violation.
 - MJ's Wine Bar – 3 calls related to MJ's

3. **New and pending Liquor Licenses:** June 20th Council Orders (attached)
 - Crooners & Cocktails – questions arose about what public property they are referring to (request for outdoor seating) - Crooners & Cocktails or a neighboring business?

4. Other:

- North Point has been granted full use of the sidewalk in front of their space because the sidewalk is not ADA compliant and would have been closed anyway. The sidewalk is set to be repaired in the fall or early next spring.
- Alen asked for detail on comment in Minute 2, last bullet on May meeting minutes about noise complaints. Don will pass this request on to Gary Hutcheson who will be returning and at the July NLOC meeting.
- Sound Oversight – Casey is meeting with Jon Jennings June 23rd to talk about the Sound Recommendation letter. Email questions you have to Sarah or Erik prior to the meeting. Casey will report back in July.
 - Doug Fuss commented that he believes that NLOC has their own bylaws. Casey will look for and circulate the bylaws to all NLOC members. Erik suggests getting clarification from both the NLOC and Portland Downtown bylaws and find out if NLOC can do independently of Portland Downtown, or if they are a standing committee of Portland Downtown.
 - Most NLOC recommendations that were presented were approved by the board and included in the Sound Recommendation letter.
- Stephanie Manning – Harvest on the Harbor. She and her business partner purchased the event from CVB. The date of the event will be 10/20 – 10/23. They would love involvement from restaurants and bars. Maine Magazine is the media partner, Full Plates, Full Potential, is the charitable partner. They hope to include downtown businesses in events, promotions and partnerships. They will sell an access pass to events going on around downtown. Stefanie proposed that businesses could offer a Harvest on the Harbor drink special, meal, etc. There is no cost to businesses to participate.
- Old Port Festival – will be taping vendor spaces rather than painting. No parking signs will be posted on Saturday afternoon. Stages are in the same locations. Some rain locations might be utilized if necessary.
- Fore St closure at 10:00pm and towing cars: PPD will experiment with closing it and ticketing but NOT towing for one month. This group thinks it is worth a try.
